3. The space as stipulated in this contract is solely for the exhibitors named in this contract during the IRF Farm Show and cannot be transferred, or any portion sublet by the exhibitor or his/her agents.
4. Every exhibit must be properly installed and ready for operation by 8:00 a.m. on the opening day of the show, August 16th and MUST REMAIN INTACT until 3:00 p.m. on the closing day, August 17th. Failure to meet these requirements may cause exhibitor to be barred from future shows.
5. Every exhibit shall be prepared in a neat and orderly style and must be kept clean by the exhibitor. No flammable material (such as crepe paper) shall be used in decorating exhibits.
6. The IRF will use all reasonable care to prevent loss or damage to exhibitor's property, but is not liable in any manner for such loss.
7. The IRF reserves the right to control the volume of any loudspeaker, radio, musical instrument or any noise making device that might interfere with other exhibitors in the immediate area. Public address systems cannot be used except by special permission.
8. No inside exhibit shall be constructed in a way that interfere's with the viewing of other exhibits.
9. The IRF reserves the right to move any exhibitor (inside or outside) to eliminate congestion.
